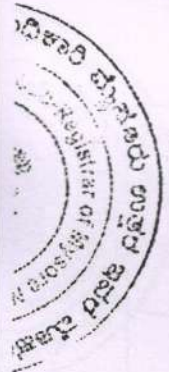
**NOW THIS SUPPLEMENTARY DEED OF TRUST WITNESSETH AS FOLLOWS:**

11. Mr. Tejas B Shankar, as a Trustee shall always act in the interests of the Trust and shall not default in his duty as a Trustee.






THIS DEED OF TRUST is made on this 31st day of July, 1994, by Sri U. GOPALAKRISHNA, son of U.S. Narayana, aged about 34 years, residing at Door No. 1409, 5th Cross, Krishnamurthypuram, Mysore on the first part to be referred to hereinafter the Author of the Trust, has hereby reposed his trust in favour of U. Rameshkrishna, son of U.S. Narayana, aged about 32 years, residing at D.No. 1409, 5th cross, Krishnamurthypuram, Mysore (2) Sri Bhavani Shanker, son of late D. Krishnamurthy, aged about 39 years, residing permanently at D.No. 487, I Cross, Chavadi Street, Mysore, (3) U. Kedarnath, son of U.S. Narayana, aged about 26 years, residing at D.No. 1417, 6th Cross, Krishnamurthypuram, Mysore, (4) Sri Narayana Prasad, son of B.S. Sunderraj, aged about 40 years, residing permanently at D.No. 110, Kuder Matha Road, Mysore, on the second part to be referred hereinafter as the Trustees by reposing the trust in the Trustees and having created the Trust by dedication of sum of Rs. 10,000/- for the benefit and enjoyment of the public at large irrespective of the Caste, creed, sex and religion in the field of education and health to be implemented by the Trustees anywhere on the soil of India to be run and managed by the Trustees under the name and style specified hereinafter. (1) Name of the Trust :

The Trust shall be " BAHUSAR NARAYAN TRUST "

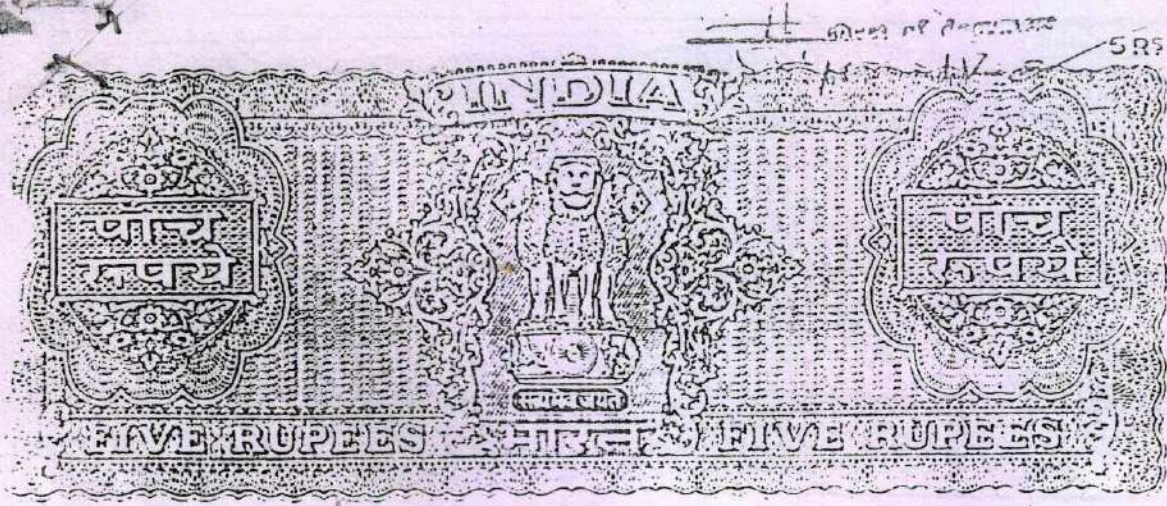
(2) Office of Trust :

(a) The registered office of the Trust shall be at 1409, 5th Cross, Krishnamurthypuram, Mysore, and thus shall be the jurisdiction over the matters for legal proceedings.

(b) The Trustees are at liberty to open branches under the registered Office in any place deem thought by the Trustees for effective administration.

(3) Aims and Objectives:

The Trust being constituted by Bahusar Kshatriya is for the purpose of spreading Kshatriya ideology and language.

(a) To start, run, establish and manage institutions for imparting education in the field of general education, commercial education, Science and Technology including natural and applied sciences, management education etc.

(b) To establish and run funds for the promotion of and development of any institutions whose objects are similar to or same as that of this Trust.

(c) To start, manage and run institutions for the publication of books, literatures and pamphlets etc., in the field of education, science and technology, management, health etc.

(d) To start, run, establish and manage institutions for research in the field of education, science and technology, management, health etc.

(e) To establish funds and distribute the realisation thereof, to award scholarships for the appropriate students as decided by the Trustees.

(f) To start, run and manage institutions, to impart studies of job orientation and health courses and craft courses for men as well as women.

(g) To establish libraries, book bureaus etc. for the use of the persons contemplated supra.

(5) Properties & Assets of the Trust :

(a) The corpus amount of the Trust is a sum of Rs. 10,000/- contributed by the Author and the same shall be deposited in the name of the Trust in any Nationalised Bank to be decided by the Trustees in their first meeting and such account shall be in the name of the Trust and to be operated jointly by the Trustees to be specified hereinafter. And through the internal arrangement arrived at by the trustees.

(b) Contributions and donations, deposits dedicated for a particular purpose within the aims and objectives of the Trust and other types of contributions, donations and all kinds of financial assistance rendered by religious, charitable, social and economic institutions.

(c) Endowment deposits and other funds that may be contributed and specifically donated by philanthropists and donors for particular purposes in their name. It is specified that the purposes so satisfied shall be one of the purposes mentioned in the aims and objectives. However, the Trustees are at liberty to receive such funds that may be given by any person for definite and particular purpose and invest it in the name of the Trust and the realisation out of the said fund shall be disbursed in accordance with the specified purpose of the donor.

(d) Interest and other sums received by the Trust.

(e) Contributions, donations, endowments and such other types of funds given, contributed and donated by individual, bodies, associations, companies, institutions and public at large.

(f) Properties whether movables or immovables acquired by the Trust by transfer, assignment, purchase, gift, donation, contributions in favour of Trust.

(g) Income of the Institutions run and managed by the Trust under the name and banner of the Trust, the contributions, donations, fees and other like income from out of the management of the Trust.

(h) Contributions or grants or aid, recurring and non-recurring either from the Government of their State or Union of India or any Commission or University, educational boards local authorities, educational foundations, religious and charitable institutions and social organisations.

(i) Such other income or resources or from other sources to and for furtherance of the objectives of the Trust.

(j) Such other property placed in the safe hands of the Trust for the purpose and utilisation for the benefit of beneficiaries to be managed by the Trust.

(k) The Trust is at liberty to borrow loans from any person, persons, individuals or corporate bodies whether private or public or from anybody under any type of contract non-repugnant to the law in force without defeating the object of the Trust for effective implementation of the purpose of the constitutions of the Trust.

(6) The Constitution and Management :

(a) The Trust is constituted with the first meeting of the Trustees. Thus the Trust become operational.

(b) The Trustees by this Deed of Trust are four in number and shall be perpetual; Trustees till their life time.

(c) The Author shall depart from Trust having created the same and the Trustee by name BHAVANI SHANKAR shall be the Managing Trustee and Trustee by name U. RAMAKRISHNA will be the Treasurer. The other shall be trustees sharing equal responsibility.

(d) In the event of the office of trustee falling vacant, the same shall be filled up by the selection and nomination of the Author during his life time and by the other Trustees. Such other Trustee who intends to fill up the vacancy so created for any reason whatsoever shall be in consonance in his life time to fulfil the aspirations of the Author.

(e) A Trustee desirous to retire or to withdraw from the Trust shall effectively serve the notice in writing clarifying the intention to so retire and shall be filled up in the manner and style specified hereinbefore.

(f) The Trust shall function in the name of the Managing Trustee, and the Managing Trustee shall act on behalf of the Trust under his name and seal and signature. The Trust shall always be addressed in the name of the Managing Trustee. Any court proceedings shall be in the name of the Managing Trustee whether such proceedings is either on behalf of the Trust or against the Trust.

(g) Duties of the Trustees:

The Trustees shall

i) look after due and efficient administration, supervision, management of all properties and the institution of the Trust.

ii) take all policy decisions pertaining to the Trust.

iii) appoint committees or sub-Committees, to manage the institutions that are run by the Trust to suit the rules and regulations of the State Authorities under whose control the institution comes.

iv) have the power of Authority to remove and nominate any member of the sub-committee constituted for the purpose stated above.

v) shall have the power to annul and modify or set aside any decision that would have been taken by the Sub-Committee and such decision shall bind the Sub-Committee.

vi) have the power to raise funds on the securities or the properties of the Trust to meet the funds that may become necessary, in due implementation of the schemes of the Trust.

vii) consider and approve the accounts of the Trust periodically once in every year, after getting the accounts scrutinised and audited by a Chartered Accountant.

viii) power to fill up the vacancies out of the persons who, in the opinion of the Trustees, is a like minded person who can strive for and serve the cause of the Trust, and

ix) frame such rules and regulations that may be required for the effective implementation of the Trust.

(7) Power of the Managing Trustee:

(a) The Managing Trustee shall represent the Trust in all the matters pertaining to the Trust and shall be the incharge of day-to-day administration and the acts of the Trust. He shall be supervisory and Executive Head of the Trust and shall take all such decisions that may become necessary for the benefit of the Trust. And all such acts during the course of business of trust shall be ratified by the other Trustees in their next meeting.

(b) The Managing Trustee shall have the power to receive money by way of advances, loans or such other type of transactions between any individual or corporations, bodies or associations, or any person that the Managing Trustee chooses and for the purpose of and on behalf of the Trust either within his soil or from any country by consent from other trustees.

(c) The Managing Trustee shall have the power to represent the Trust in due execution of all kinds of documents that may become necessary in furtherance of objectives of the Trust, along with treasurer Sri U. RAMAKRISHNA.

(d) The Managing Trustee shall represent the Trust with all the Government offices, statutory bodies, local authorities, courts and tribunals and other offices to prosecute or defend the interest of the Trust and to sue and be sued.

(e) The Managing Trustee shall have the power to open the accounts in Banks or Financial Institutions or other authorities, or the Government bodies in accordance with law in force along with the Treasurer by name U. RAMAKRISHNA and such accounts in the name of the Trust shall be operated by the Managing Trustee along with the Treasurer Sri U. RAMAKRISHNA.

(f) The Managing Trustee shall have the power to sign all kinds of papers and correspondences, not relating to financial transaction.

TREASURER:

(a) The Treasurer shall sign all the documents and papers involving direct and proximate, monetary involvement of the Trust.

(b) The Managing Trustee and Treasurer shall operate the Bank accounts, and shall represent the Trust on the monetary funds with due knowledge of Treasurer.

(c) The Treasurer is responsible for the accounts and management of Trust fund.

(9) Bank Accounts:

(a) The Trust shall maintain one or more banking accounts in the name of the Trust in any Bank or Financial Institutions, recognised by the State or by the appropriate authority.

(b) The Trustees are at liberty to open any kind of account with the financial institutions that may become necessary in effective implementation of the objectives with due knowledge of other Trustees, and particularly after approval by Treasures.

(10) Meetings:

(a) The Trustees shall meet atleast once in a month.

(b) The quorum of the meeting shall be satisfied by the presence of any two of the Trustees.

(c) The Managing Trustee shall head such meetings and in the absence of the Managing Trustee, the Treasurer and such person head of meetings, shall record the minitues.

(d) The meetings shall peruse the accounts from time to time and shall finalise the accounts of the financial year in a period not exceeding 3months from the completion of such financial year.

(e) The meetings shall be convened by the Managing Trustee with a notice of 7 days to the Trustees and such notice shall be duly and effectively served with an acknowledgement by the Trustees and by Trustee if need by so by intimating other Trustees of the subject that will be taken up in such meeting.

(f) The Managing Trustee is empowered to summon emergency meetings of the Trustees with a minimum notice of 24 hours.

(11) Financial Year:

The financial year of the Trust shall be from 1st day of April of every year to the 31st day of March of every succeeding year.

(12) Books of Account and Audit:

(a) The Managing Trustee shall maintain or cause to be maintained all kinds of registers, books and other records of accounts and receipts and expenditures, assets and liabilities of the Trust and shall draw up an income and expenditure account for each year at the end of financial year and balance sheet shall be prepared which shall also be verified and ratified by the Treasurer.

(b) The accounts so drawn up shall be audited from time to time by a qualified Chartered Accountant and shall be perused and approved subject to reservation by the Trustees.

(13) Revocation and Dissolution of the Trust:

(a) This Trust having created for a perpetual existence shall be revocable.

(b) In the event of the Trust becoming non-functional due to paucity of funds or incapacitated for any reason whatsoever and thus failing to implement the ambitious, objectives of the Author of the Trust, the Trustees are at liberty to dissolve the Trust and thus hand over and make over the assets of the Trust to any other Trust having similar objectives.

(14) Indemnity:

The Trustees are all Honorary functionaries in their respective capacities and are thus not entitled to any remunerations in any name and style whatsoever and thus are indemnified out of the Trust fund towards any costs of any proceedings, expenses, claims and liabilities in satisfying the objectives of the Trust incurred during the course of functioning as a Trustee and are not liable at their individual costs.

(15) Investments:

The Trustees are at liberty to invest in any manner subject to provisions of the Income Tax Act.

(16) Disciplinary Actions:

(a) The Trustees shall be rendered non-functional and be suspended in contemplation of enquiry and in the event of finding guilty of any act of unbecoming of a Trustee defeating the purpose of the Trust shall

be expelled thereafter.

(b) The Trust shall have the power to suspend, terminate any of its employee or employees or any managerial functionaries from the institutions under the Trust and such action shall be after a due enquiry and till such time such due enquiry is conducted, such persons subjected to such punishment shall be kept in suspension, whether or not, such persons under the Trust or Institutions under the Trust are directly appointed by the Trust or not.

(17) Amendments:

The Trustees are at liberty to carry out amendments, to the rules and regulations laid under this Deed or any other rules and regulations formulated for effective management without altering the basic nature and desire of the Trust.
